

In addition to ultrafast recovery time, the HEXFRED® product line features extremely low values of peak recovery current (IRRM) and does not exhibit any tendency to "snap-off" during the th portion of recovery. The HEXFRED features combine to offer designers a rectifier with lower noise and significantly lower switching losses in both the diode and the switching transistor. These HEXFRED advantages can help to significantly reduce snubbing, component count and heatsink sizes. The HEXFRED VS-HFA25TB60S is ideally suited for applications in power supplies and power conversion systems (such as inverters), motor drives, and many other similar applications where high speed, high efficiency is needed.




Fig. 1 - Maximum Forward Voltage Drop vs. Instantaneous Forward Current




Fig. 2 - Typical Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics




Fig. 5 - Typical Reverse Recovery Time vs. dl_F/dt




Fig. 6 - Typical Recovery Current vs. dl_F/dt




Fig. 7 - Typical Stored Charge vs. dl_F/dt




Fig. 8 - Typical dl_{(rec)M}/dt vs. dl_F/dt





Fig. 9 - Reverse Recovery Parameter Test Circuit

$$Q_{rr} = \frac{t_{rr} \times I_{RRM}}{2}$$


(5) dI_{(rec)M}/dt - peak rate of change of current during t_b portion of t_{rr}
